

The Clermont Town Council met on June 7, 2016. The Mayor called the meeting to order at 7:00pm. Present: Mayor, James Nix, Council Members, Seth Weaver, Kristi Crumpton, Doug Myers and Margaret Merritt. Town Clerk, Sandra Helton.

APPROVAL OF AGENDA: Seth Weaver made a motion to approve the agenda. Kristi Crumpton seconded, and all Council members present voted in favor. Motion passed.

INVOCATION AND PLEDGE OF ALLEGIANCE: Seth Weaver gave the invocation and Mayor Nix led the Pledge of Allegiance.

PUBLIC HEARING FOR 2016-2017 BUDGET: The budget for FY 2016-2017 that begins July 1, 2016 is being proposed at \$327,600.00. Mayor Nix asked for question or comments and with there being none stated the hearing would remain open for twenty minutes.

MINUTES: Seth Weaver made a motion to approve the May 2016 Minutes. Kristi Crumpton seconded, and all Council members present voted in favor. Motion passed.

MINUTES: SPECIAL CALLED MEETING: APRIL 2016 Seth Weaver made a motion to accept the minutes from the April Special Called Meeting. Kristi Crumpton seconded and all Council members present voted in favor. Motion passed.

FINANCIAL STATEMENT: Seth Weaver made a motion to approve the April 2016 Financial Statement. Doug Myers seconded, and all Council members present voted in favor. Motion passed.

REPORT: ORDINANCE 97-01 PLANNING AND ZONING: The Mayor and Council reviewed this report.

SECOND READING OF REVISED FIREWORKS ORDINANCE 82-2016-05-01: AN ORDINANCE TO AMEND THE ORDINANCES OF THE TOWN OF CLERMONT, GEORGIA, TO REGULATE THE SALE, USE, IGNITION OF, POSSESSION, MANUFACTURE, TRANSPORT OR THE STORAGE OF, ANY CONSUMER FIREWORKS OR FIREWORKS TO THE EXTENT PERMITTED BY THE GENERAL LAW OF THE STATE OF GEORGIA. Seth Weaver made a motion to accept the second reading of Ordinance 82-2016-05-01. Doug Myers seconded, and all council members present voted in favor. Motion passed.

FIRST READING OF ORDINANCE 2016-07-01: AN ORDINANCE PROVIDING FOR THE 2016 SPECIAL ELECTION FOR THE TOWN OF CLERMONT, GEORGIA. Mayor Nix gave the first reading of the Special Election Ordinance and explained this would be held to fill Eric Thomas seat who resigned on April 4, 2016. The person who is elected will hold this seat until December 2019.

Seth Weaver made a motion to accept the first reading of Ordinance 2016-07-01. Doug Myers seconded, and all Council members present voted in favor. Motion passed.

ADOPT 2016-2017 BUDGET: Kristi Crumpton made a motion to adopt the 2016-2017 Budget on the amount of \$327,600.00. Seth Weaver seconded, and all Council members present voted in favor. Motion passed.

ADJOURN: Seth Weaver made a motion to adjourn at 7:23 pm. Doug Myers seconded, and all Council members present voted in favor. Motion passed.
