REPORT: ORDINANCE 97-01 PLANNING AND ZONING: The Mayor and Council reviewed this report.



Council member Kristi Crumpton asked if we could have a special called meeting regarding a straw vote to be placed on the ballot if the letter to Rep. Lee Hawkins was not sufficient. Mayor Nix said we could have a called meeting.
