

The Clermont Town Council met on February 7, 2019. The Mayor called the meeting to order at 7:00 pm. Present: Mayor, James Nix, Council Members, Doug Myers, Marcia Kesler, Cynthia Jett, and James Castleberry. Town Clerk, Amy Lomax, Assistant Town Clerk, Robin Bryson.

APPROVAL OF AGENDA: Mayor Nix requested that the agenda item off-site computer back-up be added to the agenda. James Castleberry made a motion to accept the agenda with the changes. Cynthia Jett seconded, and all Council members present voted in favor. Motion passed.

INVOCATION AND PLEDGE OF ALLEGIANCE: James Castleberry led the invocation, and Mayor Nix led the Pledge of Allegiance.

MINUTES- JANUARY 2019: Marcia Kesler made a motion to accept the January 2019 Minutes. Doug Myers seconded, and all Council members present voted in favor. Motion passed.

FINANCIAL STATEMENT: The Mayor and Council reviewed the December 2018 Financial Report.

REPORT: ORDINANCE 97-01 PLANNING AND ZONING: The Mayor and Council reviewed this report.

SECOND READING OF PLANNING AND ZONING ORDINANCE 82-2019-01-01: Mayor Nix gave the second reading of Ordinance 82-2019-01-01. This is an ordinance to amend the planning and zoning ordinances for the Town of Clermont, Georgia; to repeal prior planning and zoning ordinances and to adopt a new planning and zoning ordinance for the Town of Clermont, Georgia; to incorporate by reference the Planning and Zoning ordinance for the Town of Clermont, Georgia by way of this adoption ordinance; and for other purposes. Mayor Nix asked if anyone had any comments or questions. With no discussion, James Castleberry made a motion to accept Ordinance 82-2019-01-01. Doug Myers seconded, and all Council members present voted in favor. Motion passed.

GALLERIA BUILDING: James Castleberry made a motion that the Council abandon the idea of the Galleria Building being used for the new Town Hall and the building be sold. Cynthia Jett seconded. James Castleberry, Cynthia Jett, and Marcia Kesler voted in favor, Doug Myers voted against. The motion passed 3-1.

OFF-SITE COMPUTER BACK-UP: The Mayor discussed with the Council a Quote from ACNS Inc. the company that currently does computer security for the Town. The quote was \$30.00 per month for continuous off-site back-up of the two computers located in the Town Hall. James Castleberry made a motion to accept the quote from ACNS Inc. Cynthia Jett seconded, and all Council members present voted in favor. Motion passed.

ADJOURN: James Castleberry made a motion to adjourn at 7:25 pm. Cynthia Jett seconded, and all Council members present voted in favor. Motion passed.
