## Town of Clermont Town Council Meeting November 7, 2023

The Clermont Town Council met on November 7, 2023. The Mayor called the meeting to order at 7:00 p.m. Present: Mayor James Nix, Council Members Seth Weaver, James Castleberry, Doug Myers, Marcia Kesler, and Amanda Nix. Town Clerk Amy Lomax also attended.

**APPROVAL OF THE AGENDA:** Doug Myers motioned to approve the agenda. Marcia Kesler seconded, and all Council members voted in favor. Motion passed.

**INVOCATION AND PLEDGE OF ALLEGIANCE:** Council Member Seth Weaver led the invocation, and Mayor Nix led the Pledge of Allegiance.

**MINUTES-OCTOBER 2023:** James Castleberry motioned to accept the October 2023 Minutes. Marcia Kesler seconded the motion, and all Council members voted in favor. Motion passed.

**FINANCIAL STATEMENT:** The Mayor and Council reviewed the September 2023 Financial Report.

**REPORT: PLANNING AND ZONING:** The Mayor and Council reviewed this report.

**SECOND READING OF NOISE ORDINANCE NO. 82-2023-10-07** The Mayor gave the second reading of Noise Ordinance 82-2023-10-07. This is an ordinance to regulate noise within the Town of Clermont, Georgia; to provide an ordinance title; to provide for definitions; to provide for the purpose, intent, and measurement standards; to provide noise control regulations; to exclude certain sources of noise; to provide for the registration of outdoor entertainment events; to provide for penalties; to provide an effective date; to repeal conflicting ordinances; and for other purposes. Seth Weaver made a motion to approve the Noise Ordinance 82-2023-10-07. James Castleberry seconded, and all Council Members voted in favor. Motion passed.

**PARK CORNER OF KING/CARTER STREET:** Council Member James Castleberry presented several quotes to the Council for constructing a 12x12 pavilion on the corner of King/Carter Street and two quotes for pouring a 12x12 concrete pad and walkway.

Marcia Kesler motioned to approve \$12500.00 for constructing the pavilion, concrete pad, and walkway. Seth Weaver seconded the motion, and all Council Members present voted in favor. Motion passed.

**PROJECT UPDATES:** Town Clerk Amy Lomax informed the Council that the playground installation should begin on Monday, November 13<sup>th</sup>. She reminded the Council that the Christmas Parade and Tree Lighting are planned for Saturday, November 25<sup>th</sup>. Mayor Nix invited the Council to attend the Veterans Day program on Friday, November 10<sup>th</sup> at 10:00 am.

**PUBLIC COMMENTS:** The Mayor asked the audience if anyone had any comments. Jim Hammock introduced himself to the Council. He will be running for the office of Hall County Sheriff in the next election. The mayor asked if anyone else would like to say anything. With no further comments, the mayor called for the meeting to be adjourned.
